## The Architectural League of New York elects Mario Gooden as its 63rd president

New York, July 1, 2022 – At its 141st Annual Meeting held last night at the Harlem School of the Arts, The Architectural League of New York elected Mario Gooden as its 63rd president. Gooden is a cultural practice architect and director of Mario Gooden Studio: Architecture + Design, as well as Professor of Practice at the Graduate School of Architecture, Planning and Preservation at Columbia University. At Columbia he is also interim director of the Master of Architecture program and co-director of the Global Africa Lab. His practice engages the cultural landscape and the intersectionality of architecture, race, gender, sexuality, and technology. Gooden's work has been exhibited nationally and internationally, at venues including the Venice Biennale, the National Building Museum in Washington, and the Museum of Modern Art, where his multi-media installation The Refusal of Space was featured in the exhibition Reconstructions: Architecture and Blackness in America. He is the author of Dark Space: Architecture Representation Black Identity, as well as many essays and articles on architecture, art, and cultural production. Current design projects in the office include the Woodson African American Museum of Florida in St. Petersburg.

Gooden succeeds Paul Lewis, principal of LTL Architects, who served as president of the League from 2018-2022. Major initiatives at the League during Lewis's term included the creation of Reimagine, a program that engaged recent architecture school graduates, during the first summer of the Covid-19 pandemic, in a series of workshops and conversations to imagine new futures for architectural education and the profession. Lewis played a catalytic role in the creation of the US chapter of the international movement Architects Declare, on climate change, biodiversity, and justice. The League also published nine reports from the new American Roundtable project, which examines the interaction of the constructed environment with economic, health, and other issues in selected small city and rural areas around the country. The League's annual competitions and lecture series spotlighting significant work have all been transformed over the last several years to expand their audiences and the models of architecture that are presented or premiated.

Also elected at the Annual Meeting were Quilian Riano, as Vice-President for Architecture; Torkwase Dyson and Kris Graves, as Vice-Presidents for Visual Arts; Mabel O. Wilson, as Vice-President for History, Theory, and Criticism; Stella Betts, as Secretary, and members of the 2025 Class of directors of the League: Vishaan Chakrabarti, Frances Halsband, Andy Klemmer, Ersela Kripa, Joseph Mizzi, Thomas Phifer, Brad Samuels, Ken Smith, Calvin Tsao, Sarah Williams. In addition to the election of officers and directors, the Annual Meeting featured The Henry N. Cobb Annual Meeting Address, a commissioned lecture that considers pressing current issues in architecture and architectural education. The address was given by J. Meejin Yoon, Gale and Ira Drukier Dean of the College of Architecture, Art, and Planning at Cornell University and a principal in the architectural firm Höweler+Yoon. Yoon's address was titled "What's the Matter?"

The meeting began with remarks about and a tour of the recently reimagined Herb Alpert Center of the Harlem School of the Arts, conducted by Celia Imrey, who led the design team that renovated and renewed the facility in 2020.
